Deklaracja zgodności REACH

Niniejszym Firma Metall-Expres Sp. z o.o. oświadcza, że jej wyroby, wykonane z miedzi, spełniają wymagania Rozporządzenia (WE) nr 1907/2006 Parlamentu Europejskiego i Rady z dnia 18 grudnia 2006 r. w sprawie rejestracji, oceny, udzielania zezwoleń i stosowanych ograniczeń w zakresie chemikaliów (REACH) i utworzenia Europejskiej Agencji Chemikaliów, wraz ze wszystkimi zmianami i uaktualnieniami.

Na podstawie raportu TR2142580 stwierdzamy, że przedmiot badań opisany jako **Copper wire Cu-OF, Cu-OFE, Cu-ETP, copper flat bar, copper profile, copper rod Cu-OF, Cu-OFE, Cu-ETP** nie zawiera żadnych substancji stanowiących bardzo duże zagrożenie (SVHC¹) wymienionych na liście kandydackiej ECHA w stężeniach większych niż 0,1% (1000 ppm). Tym samym wymóg zawarty w artykule 7(1)(b) rozporządzenia REACH dotyczący rejestracji substancji zawartych w wyrobach nie ma w tym przypadku zastosowania.
